



# Pro Series, IceBreaker, and Ultra Limited Parts Warranty

**Limited Parts Warranty** – Commercial Gutter Incorporated (*herein referred to as CGI*) warrants to the original owner(s) that its specially designed Gutterglove® (*herein referred to as GG*) gutter guards will not be defective in manufactured parts, and agrees that it will, at its option only, either repair the broken part or replace it with a new or reconditioned equivalent. This Limited Warranty is valid for 25 years for the Gutterglove Pro Series and Gutterglove IceBreaker, and 15 years for Gutterglove Ultra, for their parts only and does not include cost of labor for re-installation or shipping costs. All of the above named items are subject to the following terms and conditions. No other warranty is expressed or implied in this Limited Warranty. You may also have other rights which vary from state to state. **Note: This Limited Warranty is valid for only 10 years (not 25 years) on all the above mentioned gutter guards if GG is installed directly by the end user (homeowner or their handyman installer) and not a Certified GG Installer.**

**Coverage Exclusions and Limitations** – The above mentioned warranties are void if any of the following conditions occur: Improper installation; settlement of building structure; Structural shrinkage or distortion of structure (*Example: warping of roof or gutter over time etc.*); Vandalism; Hail; Fire; Tornado; Windstorm; Earthquakes; Lightning; Protective liquids or any type of roof preservation product applied to roof tops to extend the life of a roof; Maintenance Procedures are not followed properly; Tree sapping on mesh; Insect/bird droppings on mesh; Accidental damage; Acts of God; Misuse or abuse of the gutter guard; Mildew accumulation; Paint overspray; Moss or algae growth accumulation; Impact of foreign objects; Normal weathering; Caustic atmospheric conditions (*Example: Acid rain, harmful chemicals, etc.*) or any other causes beyond the control of CGI. Note: Icicles can form in extreme cold weather where snow is present except when using Gutterglove IceBreaker, our heated gutter guard. Gutterglove Icebreaker: This warranty does not cover any electronic parts that are installed in/on Gutterglove IceBreaker. See the heat-cable manufacturer’s warranty.

CGI’s obligation under this warranty shall at no time exceed the original purchase price of this product at time of sale, but not for installation or re-installation costs. These warranties cover only GG gutter guards and do not cover the gutter or any part of the building structure.

CGI reserves the right to withdraw this warranty from the market at any time. Any and all warranties in effect at the time of removal will not be affected by the withdrawal, and will remain in effect until their expiration. This warranty is valid for the original purchaser.

CGI cannot and will not be liable to the original purchaser for a breach of any written or oral express warranties, such as those given to you by a GG dealer, contractor, sub-contractor or installer of GG gutter guards. Any implied warranties imposed by law, such as the implied warranties of merchantability and fitness for a particular purpose are limited in time to the duration of this warranty. CGI shall not be liable for any consequential damages for breach of any express, written, oral, or implied warranty on any GG gutter guard. Your exclusive remedy shall be repair or replacement solely at CGI’s option, only on terms stated in this warranty. Some states do not allow the exclusion or limitation of incidental or consequential damages and some states do not allow limitations on how long an implied warranty lasts, so the above limitations or exclusions may not apply to you.

**Registration of Warranty** – This warranty becomes effective when the GG installer and the owner complete this warranty application and mail it to the GG corporate office within 60 days after the installation is complete. Failure to do so will render this warranty null and void.

**Claims Procedures** – Any claim made hereunder must be presented to CGI within the warranty period within a reasonable period of time after discovering the defect.
